Presentation:

Cutaneous foam containing minoxidil 50mg/g (5% w/w).

Uses:

Treatment of alopecia androgenetica in men aged 18 to 49.

Dosage

1g twice daily to affected areas of scalp. Maximum dose 2g in 24 hours.

Contraindications:

Hypersensitivity to ingredients. Hypertension, scalp abnormality, shaved scalp, occlusive dressings on scalp or other topical medications. Also contraindicated for use in women.

Precautions:

For external use only on normal healthy scalp. Wash hands thoroughly after application.
