### Uses:

Treatment of alopecia androgenetica in men aged 18 to 65.

## Dosage:

1ml twice daily to affected areas of scalp. Maximum dose 2ml in 24 hours. **Contraindications:** 

Hypersensitivity to ingredients. Hypertension. Scalp abnormality. Shaved Scalp. Occlusive dressings on scalp or other topical medical preparations being used. Also contraindicated for use in women.

## Precautions:

For external use only on normal healthy scalp. Wash hands thoroughly after application.
